For this, Blue Rickshaw will share with JKTPO the list of documents required for onboarding and has asked JKTPO to provide the database of highquality sellers (artisans, weavers, MSMEs who handcraft the product) with them so that Blue Rickshaw team can connect and contact them for onboarding

B2B Meet with Etsy: In order to create forward market linkages for Artisans and MSMEs to export Jammu and Kashmir craft through e-commerce, JKTPO had a B2G

meeting with E-Commerce Company- Etsy to discuss synergies and explore convergence possibilities.

To take this initiative forward Etsy has express interest to sign an MoU with JKTPO with realistic goals to achieve the target of onboarding the sellers and their sales. For this, Etsy will share with JKTPO the list of documents required for onboarding and has asked JKTPO to provide the database of high-quality sellers (artisans, weavers, MSMEs who handcraft the product) with them so that Etsy team can connect and contact them for onboarding.

B2G Meeting with IKEA: Meeting with IKEA representative in order to understand the requirements & procedures to get associated with them. Appended are the pointers on the discussion with IKEA:

- Steady Supply of Materials
- Organized setup Aggregation, cooperative setup
- Legal + Social Compliances from sellers
- IKEA wants a long-term engagement
- IKEA wants 300 people in one place instead of 20 to ensure Steady Supply
- Also need to think on how we can diversify supply risk; Product Diversification is key. Eg. Carpet to Cushion, Cushion covers, Crewel Products
- Commercial viability is to be figured

IKEA has agreed to visit Srinagar to understand the product quality & sellers potential.
